1. Introduction

b. Automatically Collected Information

- IP address, browser type, device ID
- OS version, device type, language settings
- Access time, usage logs, clickstream data

c. In-App Behavior and Communications

- Likes, matches, messages, super likes, gifts
- Travel offers and interactions with other users
- Reports, flags, or user moderation events

d. Payment Data

- Transaction history
- Subscription status
 (Payment processing is handled via App Store / Google Play and not stored by us directly.)

3. How We Use Your Information

We use your information for the following purposes:

- To register and manage your account
- To match you with other users
- To facilitate messaging and user interaction
- To provide personalized content and suggestions
- To process subscriptions and transactions
- To detect and prevent fraud or misuse
- To improve the performance and user experience of the Platform
- To comply with legal obligations
- To serve targeted and contextual advertisements
- To respond to user support or law enforcement requests

4. Legal Basis for Processing (Under GDPR)

We process your personal data based on one or more of the following legal grounds:

- Your consent (Article 6(1)(a))
- Performance of a contract (Article 6(1)(b))
- Legal obligation (Article 6(1)(c))
- Legitimate interest, provided it does not override your rights (Article 6(1)(f))

You may withdraw your consent at any time without affecting the lawfulness of prior processing.

6. Who We Share Your Data With

We may share your personal data with:

- Cloud hosting and data storage providers
- Analytics and performance monitoring tools
- Advertising partners (e.g., Google, Meta)
- Customer support and moderation tools
- Third-party service providers that assist in app operations
- Legal or government authorities where required

We do not sell your personal data.

7. International Data Transfers

Your personal data may be transferred and stored outside your country of residence, including to countries that may not offer the same level of data protection.

We rely on your **explicit consent** for such transfers, as required under **Article 49(1)(a) GDPR**.

8. Data Retention

- We retain your personal data as long as your account is active or as necessary to provide you services.
- If you delete your account, we will delete or anonymize your data, unless legal retention is required.
- Some metadata or anonymized usage data may be retained for analytical purposes.

9. Your Privacy Rights (GDPR)

If you are located in the EU/EEA or UK, you have the right to:

- Access the personal data we hold about you
- Request correction or deletion of inaccurate or unnecessary data
- Withdraw consent where processing is based on consent
- Object to or restrict certain processing activities
- Data portability
- Lodge a complaint with a data protection authority
